

MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION  
between

TOKYO UNIVERSITY OF SCIENCE

and  
Faculty of Science  
CHAUDHARY CHARAN SINGH UNIVERSITY, MEERUT  
INDIA

The Graduate of School of Science, Tokyo University of Science, hereinafter referred to as TUS, and the Faculty of Science, Chaudhary Charan Singh University, Meerut, hereinafter referred to as CCSU, Meerut, recognizing that academic exchange and collaboration would promote the development of research and education at the two institutions, have concluded the following Memorandum of Understanding, hereinafter referred to as MoU.

**Article 1**

The two institutions agree to develop the following collaborative activities in academic areas of mutual interest, on a basis of equality and reciprocity:

- (a) Exchange of faculty members
- (b) Exchange of students
- (c) Planning and implementation of academic collaboration, including joint research and joint conferences
- (d) Exchange of academic information and publications
- (e) Promotion of other academic activities

**Article 2**

The two institutions acknowledge that visits by faculty members and students from one institution to the other shall be subject to the regulations of Japan and India, and shall comply with the rules and regulations of TUS and CCSU, Meerut.

**Article 3**

Each institution may send up to two faculty members for each academic year to the other institution. A balance in the number of faculty members exchanged shall be sought over the five-year period governed by this MoU. The duration of a faculty member's stay shall not exceed one month. At TUS, the academic year begins in April and ends in March. At CCSU, Meerut, the academic year begins in July and ends in June.

**Article 4**

The two institutions agree that all expenses, including those associated with international travel, per diem and all other costs for visiting faculty members, shall principally be the responsibility of the home institution.

## Article 5

Visiting faculty members shall be responsible for purchasing travel and health insurance which is effective in the host country and covers them for the entire period of their stay.

## Article 6

Each institution may send graduate students as non-degree students at the other institution for research purposes only. The number of students sent by an institution shall not exceed, in aggregate, 24 man-months of enrollment per year. A balance in the number of students exchanged shall be sought over the five-year period governed by this MoU. The duration of a student's stay shall not exceed twelve months and shall not be shorter than one month.

## Article 7

Students with better than average academic credentials shall be selected by their home institution on the basis of academic merit and suitability for study at the host institution. The names and details of the students shall be submitted to the host institution prior to acceptance for approval. The host institution reserves the right to reject candidates, in which case additional candidates may be proposed.

## Article 8

A certificate of student performance will be provided to the home institution upon request.

## Article 9

Students shall have the rights and privileges enjoyed by all students of the host institution.

## Article 10

Students shall be exempt from paying tuition and academic fees to the host institution.

## Article 11

The two institutions agree that all expenses, including those associated with international travel, living expenses, and all other costs for visiting students, shall principally be the responsibility of the home institution.

## Article 12

Students shall be responsible for purchasing travel and health insurance which is effective in the host country and covers them for the entire period of their stay.

## Article 13

It is agreed that the particular details concerning any other agreed programs and collaboration activities based on this MoU shall be negotiated, decided, and stipulated in separate implementation agreements.

## Article 15

Neither institution shall use the name or logo of the other institution for any purpose whether in relation to any advertisement or other form of publicity without obtaining the prior written consent of the other institution.

## Article 16

All information furnished in relation to this MoU by one institution to the other, which is clearly identified as proprietary or confidential at the time of disclosure, will be kept confidential by the receiving institution, and will not be disclosed to any third party except when necessary to carry out the provisions of this MoU, unless agreed in writing between the two institutions.

## Article 17

The two institutions will faithfully consult with each other and do their utmost to resolve any difficulties concerning the cooperation stipulated in this MoU.

### Article 18

The period of effect for this MoU shall be five years from the date on which the latter institution's signature has been executed. If either institution wishes to terminate this MoU before the end of the five-year period, written notice must be given at least six months prior to the desired termination date. In the event of early termination, both institutions agree to honour any ongoing activities until the completion of those activities. Either institution may initiate amendments to this MoU, but both institutions must agree to such amendments in writing before they take effect. At the end of the five-year period, this MoU may be renewed upon mutual written consent of both institutions.

This MoU is signed in duplicate in English and each institution shall retain one copy.
