



## Memorandum of Understanding

**Chaudhary Charan Singh University, Meerut**

And

**Institute for the Advancement of Vedic Mathematics, UK**

### **CL.1 The MoU**

**CL.1.1 This MEMORANDUM OF UNDERSTANDING (MoU)** made and entered into on this ..... day of ....., by and between following parties:

**CL.1.2 Chaudhary Charan Singh University, Meerut** which expression shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as CCSU), and

**CL.1.3 Institute for The Advancement of Vedic Mathematics** is a CIO (Charitable Incorporated Organization) registered in the United Kingdom, no. 1169197, which expression shall mean and include its successors in interest and assigns of the first part (hereinafter referred to as IAVM)

### **CL.2 Preamble**

**CL.2.1** Whereas CCSU, Meerut and IAVM, have realized the need for a close linkage between the two Organizations, in order to share the common interest of disseminating the fruits of academic/scientific research in Vedic Mathematics to the benefit of the Society herewith sign this MoU on following broad understanding:

### **CL.3 General**

**CL.3.1 The Chaudhary Charan Singh University** has faculty scholars in Vedic Mathematics, who have enough capabilities to teach and conduct basic research in their areas of specialization.

**CL.3.2 The IAVM** has research scholars who have enough capabilities to teach and conduct basic research in Vedic Mathematics.

### **CL.4 Academic and Development Programmes**

**CL.4.1** The faculty of CCSU and IAVM may participate in the teaching and research programs of each other's institutions in Vedic Mathematics. To accomplish it, there may be exchange of faculty members / research students between CCSU and IAVM.

**CL.4.2** The faculty of various divisions of IAVM and faculty members of Chaudhary Charan Singh University will work towards joint research projects in area of mutual interest, thereby mutually using leading research facilities developed at **Chaudhary Charan Singh University** and **IAVM**.

**CL.4.3** Data generated through collaborative research will be published in SCI/Scopus/Peer Reviewed/UGC Care Listed journals jointly by the scientists/faculty of both the institutions.

### **CL.5 Duration and other terms of MoU**

**CL.5.1** The MoU will be effective for a period of 5 years from the date of signature. The duration may be extended with the consent of both the parties under mutually agrees terms and conditions.

**CL.5.2** A 'Nodal Officer' may be designated by either side to coordinate and function as per the modalities of MoU.

**CL.5.3** It is further agreed that the Honorable Vice-Chancellor, Chaudhary Charan Singh University and Chair, IAVM through periodic meetings will monitor the progress of this MoU. Any change/modification/termination as introduced/ suggested by the Review Committee (Comprising of Vice-Chancellor, Chaudhary Charan Singh University and Chair, IAVM) will be binding on both the organizations.

**CL.5.4** This memorandum of understanding reflects the respective institutions' commitments to terms and conditions mentioned in MoU. This memorandum of understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is given by the notifying party to the other party before thirty (30) days of the date on which the termination or the amendment is intended to become effective. The commitments, made before the date of termination of MoU, will continue to be operative


