

I, therefore, request your kind office to kindly investigate this matter and direct the concerned authorities – including Chaudhary Charan Singh University, Meerut and Janta Vedic College, Baraut – to ensure that a proper, transparent, and duly signed fee receipt is issued, reflecting the correct total amount received and its detailed bifurcation.

Your kind intervention in this matter will go a long way in upholding transparency, fairness, and accountability in the financial practices of higher education institutions.


