Dear Ma'am / Sir,

As you are aware Hon'ble Supreme Court of India vide its judgment dated 24.03.2025 in the matter of Amit Kumar & Ors. vs. Union of India & Ors., has constituted a National Task Force (NTF) to address Mental Health concerns of students and prevent the commission of suicides in HEIs under the Chairmanship of Justice (Retd.) S. Ravindra Bhat, Former Judge, Supreme Court of India.

2. Vide its order dated 15.01.2026, Hon'ble Court had inter-alia issued a number of directions for appropriate and immediate action by all State/UT Government, Regulatory Bodies, Higher Educational Institutions and concerned Ministries/Departments. The order was circulated vide my D.O. letter of even number dated 05.02.2026 and OM dated 15.06.2026 for taking necessary action as per the court's directions.

3. Now, vide its order dated 30.07.2026, Hon'ble Court has inter-alia directed all the Union/States/Union Territories to file compliance/action taken reports in the following format :-

4. Hon'ble Court has also directed that the compliance affidavit be filed on or before 01.09.2026. It has also been directed that once the compliance affidavits are filed by all the States/Union Territories/Union, one set of all such affidavits be provided to the learned Amicus Curiae well in advance, i.e., well before the matter is to come up on 01.09.2026.

5. In view of the above, I would request you to kindly accord priority on the matter and file affidavit in the Hon'ble Court on or before 01.09.2026 and also provide one set of such filed affidavit to the learned Amicus (Ms. Aparna Bhat, email: - aparna.bhat@gmail.com , ntf-education@gov.in & arpitaanand12@gmail.com) well before 01.09.2026, as per Court's direction.

UPON hearing the counsel the Court made the following

O R D E R

1. We heard Ms. Aparna Bhat, the learned *Amicus* and other learned counsel appearing for various parties.
2. We are informed by the learned *Amicus* that the National Task Force is preparing its final report. The Task Force would be finalizing the final report in near future and would place it before us for our consideration. However, according to the learned *Amicus*, the Order passed by this Court dated 27th May, 2026 has not been complied with by some of the States.
3. Learned *Amicus* has provided us with the following chart:-

NOTE-

Although the State of Uttarakhand was not mentioned in I.A. No. 95105 of 2026, a subsequent cross-verification undertaken pursuant to the Order dated 27.05.2026 has revealed that the State has likewise failed to comply with the directions contained therein. This lapse was duly communicated to the State authorities, however, the compliance remains pending till date.

4. The learned counsel appearing for the State of Meghalaya submitted that they have furnished the necessary information required by the Task Force today. If that be so, the learned Amicus may look into it.

5. We grant one last opportunity to the States of Himachal Pradesh, Mizoram, Odisha and Telangana to furnish the required information. If information is not provided within a period of two weeks from today, we shall take appropriate steps in accordance with law for non-compliance of our directions.

6. We direct the State of Uttarakhand also to furnish the necessary information as required by the Task Force within a period of two weeks from today.

7. Registry shall communicate this Order to all the States, referred to above, at the earliest.

IA No.209985/2026 - for directions:-

1. Taking into consideration the averments made in the said application, relief as prayed for is granted.

2. The Ministry of Education, Government of India shall release and disburse a sum of Rs.10,00,000/- (Rupees Ten Lakh only) towards the functioning and operational expenses of the National Task Force constituted vide Judgment dated 24/03/2025 within a period of one week from today.

3. The amount shall be deposited by the Ministry of Education into the Bank Account of the National Task Force having details as mentioned in Para 4 of the application.

4. We direct all the Union/States/Union Territories to file compliance/action taken reports in the following format:-
